Notification

In exercise of the power conferred under By-Laws No 35 of Tea Board By-Laws, 1955 the competent authority of the Board has been pleased to delegate the power to receive relevant applications and grant permit for planting, replacement and extension planting to following officers subject to the conditions that provisions of Tea Act, 1953, Tea Rules, 1954 and Tea Board By-Laws, 1955 shall be complied with:

1	Executive Director, Guwahati	Entire North Eastern states
2	Deputy Director of Tea Development, Siliguri	Bihar, Sikkim, Chhattisgarh, Jharkhand and Districts of Darjeeling (undivided) and Uttar Dinajpur of West Bengal
3	Deputy Director of Tea Development, Jalpaiguri	Districts of Jalpaiguri, Cooch Behar, Alipurduar of West Bengal
4	Deputy Director/ Assistant Director of Tea Development, Palampur	Himachal Pradesh and Uttarakhand

2. Data relating to tea area shall be reported to Head office as required.
3. The power to issue planting permit for South India as delegated earlier shall continue.
4. The above delegation of power shall come into force with immediate effect.
