CIRCULAR

Sub: Validity of NOC for setting up new manufacturing units/ capacity enhancement of existing manufacturing units-regarding

As approved by the Competent Authority, the following norms shall henceforth be followed for all cases regarding issuance of NOC for setting up new manufacturing units/ capacity enhancement of existing manufacturing units:-

- 1) NOCs shall henceforth be issued with the validity of 2 Years from the date of issuance of such NOCs.
- 2) Grant of further extensions shall be allowed for a maximum of 4(four) tenures of 6(Six) months at a time, based on the written application from the applicant in this regard based on physical inspection report on actual status/progress of work related to the setting up of new manufacturing units/ capacity enhancement of existing manufacturing units and duly justified by the applicant and acceptable to Tea Board.
- In case, the manufacturing unit fails to complete the work by the extended period, further extension shall be granted to the applicant only on case to case basis based upon merit of the case.

This comes into force with immediate effect.
