CIRCULAR

<u>Subject: Amended guidelines for issuance of NOC and Registration for setting</u> <u>up of a new Tea Factory/Capacity enhancement of existing Tea Factory under</u> <u>the provisions of Tea Marketing Control Order, 2003 for South India</u>

For issuing NOC/RC to Tea Manufacturing Factory, a decision was taken in 237th Board Meeting held on 26.09.2018 to clarify the Saturated/ Unsaturated zone block wise and it was decided that no NOC will be given in saturated zone. Accordingly, this was notified vide letter No. 12(17)/LC/2008/Part-II dated 07.06.2019. This issue was now discussed in 242ndBoard Meeting to review the decision taken earlier in respect of issuing NOC for Tea Manufacturing Factory. Accordingly, a meeting with all concerned stakeholders was held on17.11.2020 through Video Conferencing. Detail deliberation was done. Further, a meeting was also held with the stakeholders of South India by Executive Director, Coonoor on 26th November 2020 for discussing the revised guidelines to be formed for South India. Based on the feedbacks/comments received from the stakeholders as well as field offices of the Board, the guidelines have been amended as per the criteria of 15 Km radius concept as follows.

1. Whenever application will be received for new factory or capacity enhancement, the said factory will be treated as centre of the circle and list of factories whose registration has been cancelled within the vicinity of 15 km radius in that region will be taken in account before issuance of NOC/RC. In lieu of such cancelled factories subject to compliance of existing guidelines, issuance of fresh NOC for New Factory/Capacity enhancement can be considered.

2. The applicant is required to submit his application along with the details of the cancelled factories within the vicinity of 15km radius of the proposed unit. The same will be verified by the Board's Officials as per the procedure for further processing and issuance of NOC.

3. In case of applications for setting up of Orthodox or other specialty tea production unit, the eligibility criteria of 15 km radius shall not be applicable. Issuance of NOC/RC to such applicants shall be decided by the Registering Authority on a case-to-case basis.

4. The NOC/RC shall be issued to the eligible applicants with the condition that the applicant factory will adhere to the payment of minimum green leaf price or PSF price (Price Sharing Formula), whichever is higher, to the small tea growers/suppliers.

5. No factory shall enhance their installed capacity without obtaining prior approval from Tea Board.

6. The amended guidelines are attached for circulation among the stakeholders.

7. Date of issue of this circular by Tea Board will be the effective date of implementation.

8. Fresh applications will be considered as per this circular.

9. All NOC granted prior to the date of notification will be treated as per old notification dated 07.06.2019. However, the RC shall be granted for the quantity not exceeding NOC quantity subject to fulfilment of all the conditions for issuing RegistrationCertificate.

10. The applications which have been received before publication of this circular and no NOChas been issued, the evaluation for issuing NOC will be done separately by both the methods (i.e, as per criteria fixed vide notification dated 07.06.2019 and the new notification to be published) and favourable outcome out of two methods will be considered by Tea Board.

11. This notification shall be applicable for all regions of South India.

12. Applicant shall apply for issuance of NOC/RC for the manufacturing unit to the Registering Authority through Board's egiccs portal <u>http://egiccs.teaboard.gov.in/</u>.

13. Applicant is requested to go through the Guidelines/Instructions attached herewith before applying their application complete in all respects with all requisite documents/information.

14. After receipt of application through online, the said factory will be treated as centre of the circle and list of factories whose registration has been cancelled within the vicinity of 15 km radius in that region will be taken in account before issuance of NOC/RC. An inspection format has been designed based on the feedback received from the field office and incorporated in the Board's egiccs portal.

<u>Guidelines for issuance of NOC and Registration for setting up of a new</u> <u>TeaFactory/Capacity enhancement of existing Tea Factory under the provisionsof</u> <u>The Tea Marketing Control Order, 2003 (TMCO, 2003) for South India</u>

In the year 1984, Tea (Marketing) Control Order 1984 (TMCO 1984) was notified in exercise of the powers conferred by sub section (3) & (5) of Section 30 of the Tea Act 1953. According to Para 2(k) of the said order 'registered manufacturer' means a manufacturers registered under Para 3 of the said order.

Para 3(1) of the TMCO 1984 stipulated the provision for registration by Tea Board in respect of any **tea manufacturer**engaged in the activities of manufacturing tea from tea leaf. Under clause 3(1) of TMCO 1984 Tea Board granted registration in favour of estate factories, bought leaf factories and cooperative factories since the year 1984.

On 1stJanuary 2003 Ministry of Commerce, Govt. of India, in exercise of the powers conferred by sub section (3) & (5) under Section 30 of the Tea Act 1953 and in supersession of the TMCO1984, notified Tea (Marketing) Control Order 2003 (TMCO, 2003).

Clause 3(1) of TMCO 2003 stipulates that no manufacturer shall carry on the activities of manufacturing tea without obtaining a no objection certificate under this Order in respect of each factory to be set up by him and after completion of setting up of the factory, the manufacturer shall apply for obtaining registration in respect of each such factory owned or controlled by him.

Provided that the manufacturer, who has obtained registration under the provision of the said order of 1984, shall be deemed to have been registered under provision of the TMCO, 2003.

Clause 3A (1) of TMCO, 2003 stipulates that no registered manufacturer shall carry on the activities to enhance the production capacity of the existing factory without prior intimation and obtaining the no objection certificate from the Board.

Clause 3A(2) of TMCO, 2003 stipulates that after obtaining the no objection certificate from the Board and completion of the capacity enhancement of the factory, the registered manufacturer shall apply to the registering authority in Form A for changing the registration of the extended factory.
