Sealed tenders are invited on behalf of Dy.Chairman Tea Board, Kolkata for Engagement of Security agency to provide Security guards and Supervisor at Tea Board, Kolkata

Eligibility of bidder:

Indian companies registered Partnership firm, Sole Proprietorship firm can take up tendered items of work and whose annual turnover in the last 3 (three) each financial years was more than Rupees 20 Lakh/per year are eligible to participate in this tender. Further, the bidder should have capability and experience for providing Ex-Serviceman Security personnel in Government/Semi Government organization along with its Eligibility conditions as described in detail in the tender document.

The existing agency or any other agencies who were engaged earlier in Tea Board and desirous to participate in this Tender should obtain a satisfactory performance certificate for their previous engagement from the Secretary, Tea Board which should be submitted along with the Tender. The existing agency or earlier agencies while submitting tender should write on the outer envelope of the Tender "existing agency/earlier agency and satisfactory performance certificate duly signed is enclosed".

- a) "TEA BOARD" means Tea Board India, a Commodity Board under the Ministry of Commerce and Industry, Government of India, and having its Head Office at 14 B.T.M Sarani, Kolkata 700001
- b) "The Boards" means the Dy.Chairman Tea Board, KOLKATA acting through the Secretary, TEA BOARD, and Kolkata.
- c) "The Bidder" means "Agency" or firm who participates in this tender and submits its bid.
- d) "The Agency" means the successful bidder supplying the goods and services under the contract.
- e) "Provisional acceptance letter/letter of intent" means the intention of the purchaser to place the purchase order on the bidder.
- f) "The work order shall be deemed as "Contract" appearing in the document.
- g) "The Contract Price" means the price payable to the Agency under the work order for the full and proper performance of its contractual obligations.

2. ELIGIBLE BIDDERS:

The eligible bidder shall be an Indian Company having five years experience for Engagement of EX-Serviceman Security guards and Supervisor and whose annual turnover in the last 3 (three) financial years was more than 20 Lakh/ per year. Further, the bidder should have capability and experience in Engagement of Ex- Serviceman Security personnel to provide Security guards and Supervisor.

- 1) In Government/Semi Government organization.
- 2) Capable to provide round the clock security and timely replacement of the absentees.

Bids not conforming to these conditions will be rejected outright.

3. COST OF BIDDING:

The bidder shall bear all costs associated with the preparation and submission of the bid. The Boards will in no case, be responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.

3.2 **The Bidder is expected to examine all instructions, forms, terms and specifications in the Bid Documents. Failure to furnish all information required as per the Bid Documents or submission of bids not substantially responsive to the Bid Documents in every respect will be at the bidders risk and shall result in rejection of the bid.**

4. CLARIFICATION OF BID DOCUMENTS:

A prospective bidder, requiring a clarification of the Bid Documents shall notify the purchaser in writing at the purchaser's mailing address indicated in the invitation for Bid. The purchaser shall respond in writing to any request for clarification of the Bid Documents, which is received not later than 7 days prior to the date for the submission of bids. Copies of the query (without identifying the source) and clarifications by the purchaser shall be sent to all the prospective bidders who have purchased the bid documents.

The prospective bidders may attend the PRE-BID MEET on 06.07.2017 at 3 P.M to discuss clauses in the tender document. The venue for such pre-bid meet will be Board Room of Tea Board at its given address or any other place.

5. AMENDMENT OF BID DOCUMENTS:

5.1 At any time, prior to the date of submission of bids, the purchaser may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder, may modify the bid documents by amendments.

- 5.2 The amendments shall be notified in Writing or by e-mail or FAX to all prospective bidders on the address intimated at the time of purchase of bid document from the purchaser and these amendments will be binding on them.
- 5.3 In order to afford prospective bidders reasonable time in which to take the amendments in account in preparing their bids, the purchaser may, at its own discretion, extend the deadline for the submission of bids suitably

PREPARATION OF BIDS

6. DOCUMENTS COMPRISING THE BID:

The bid prepared by the bidder shall comprise the following components:

I. Technical bid, which shall contain:

- (a) Documentary evidence established in accordance with clause 2 and 9 of these 'Instructions to Bidders' that the bidder is eligible to bid and is qualified to perform the contract if his bid is accepted.
- (b) Bid Security furnished in accordance with clause 11 and cost of tender (proof)
- (c) A clause-by-clause compliance as per clause 11.1
- (d) A Bid form duly filled in by the bidder.

II. Financial bid, which shall contain the Price schedule, completed in accordance with clause 8 & 9

7. BID FORM:

The bidder shall complete the Bid Form and the appropriate Price Schedule furnished in the Bid Documents, indicating the services to be supplied, a brief description of the services, quantity.

8. BID PRICES:

8.1 The bidder shall give the total composite price of all levies and taxes and insurance. The basic unit prices and other component prices need to be individually indicated against the services, it proposes to supply under the contract as per price schedule given in Section VIII in Indian Rupees

8.2 Prices indicated in the price schedule shall be entered in the following manner:

- i) The price of the services, Tax, Insurance and other statutory taxes payable by the bidder.
- ii) The supplier shall quote as per price schedule for all the items given in the schedule of requirement.

8.3 The prices quoted by the bidder shall remain fixed during the entire period of contract and shall not be subject to variation on any account. **A bid submitted with an adjustable price quotation will be treated as non-responsive and rejected.**

8.4 The unit prices quoted by the bidder shall be of sufficient detail to enable the purchaser to arrive at prices of services offered.

8.5 "Discount", if any offered by the bidders shall not be considered unless they are specifically indicated in the price schedule. Bidders desiring to offer discount shall therefore modify their offers suitably while quoting and shall quote clear NET PRICE taking all such factors like discount, free supply, etc into account.

8.6 The price approved by the purchaser for procurement will be inclusive of levies and taxes and insurance as mentioned in Para 8.1 above. Break-up in various heads like ED, Sales Tax, insurance, freight and other taxes paid/payable as per clause 8.2 (i) is for the information of the purchaser and any change in these shall have no effect on price during the scheduled period of delivery.

TENDER NO. 07/SECURITY/2017**9. DOCUMENT ESTABLISHING BIDDER'S ELIGIBILITY AND QUALIFICATIONS:**

9.1 The bidder shall furnish, as part of his bid documents establishing the bidder's eligibility, the following documents:

- (i) Certificate of Incorporation.
- (ii) Articles of Memorandum of Association or Partnership Deed/Proprietorship Deed.
- (iii) Registration Certificate. Private Security License, contract labour regulations.
- (iv) Annual turnover certificate for more than Rupees 20 Lakhs for last three years.
- (v) Certificate in respect of capability and experience.
 - a. To provide personnel of different categories such as Ex-Servicemen as security guard and supervisor. In Government/Semi Government organization.
 - b. All the personnel should have proper uniform.
 - c. -----(work experience description)-----

9.2 The bidder shall furnish documentary evidence that he has the financial, technical and operational capability necessary to perform the contract.

9.2a. To judge the financial capabilities, the firm shall furnish certified copy of audited balance-sheet showing turnover for last three years.

9.3 The services offered must have ability to meet the technical specifications. Necessary document to substantiate this shall be submitted along with the offer by the Agency.

10. DOCUMENTS ESTABLISHING SERVICE CONFORMITY TO BID DOCUMENTS:

10.1 Pursuant to clause 7, the bidder shall furnish, as part of his bid, documents establishing the conformity of his bid to the bid document of all goods and services, which he proposes to supply under the contract.

10.2 The documentary evidence of the goods and services conformity to the Bid Documents may be in the form of literature, drawings, data and he shall furnish:

- (a) A detailed description of the services, essential technical and performance characteristics.
- (b) A clause-by-clause compliance on the purchaser's Technical specifications and commercial conditions demonstrating substantial responsiveness to the Technical Specifications. In case of deviations a statement of deviations and exceptions to the provision of the Technical specifications shall be given by the bidder. A bid without clause-by-clause compliance of Technical specification conditions shall not be considered. The Dy. Chairman, Tea Board will be the competent authority to accept or reject such deviations. Such decisions will be taken by the Competent Authority keeping in view the materiality of such deviations. There will be a committee having technical and finance members to assist the Dy. Chairman to consider such deviations. Once decided such decisions will be binding on all the bidders.

11. BID SECURITY:

11.1 Pursuant to clause 7 the bidder shall furnish, as part of his bid, a bid security for an amount of Rs.37,500/- (2.5% of tender value) (Rupees Thirty Seven thousand Five hundred only). The bidders who are registered with National Small Scale Industries Corporation (NSIC)) under Single point Registration Scheme may be exempted from bid security. A proof regarding current registration with NSIC for the Tendered Item will have to be attached along with the bid.

11.2 The bid security is required to protect the purchaser against the risk of bidders conduct, which would warrant the security's forfeiture, pursuant to Para 11.7

11.4 A bid not secured in accordance with Para 11.1 & 11.3 shall be ***rejected by the purchaser as non-responsive.***

11.5 The bid security of the unsuccessful bidder will be discharged/returned as promptly as possible after the expiry of the period of bid validity prescribed by the purchaser, Pursuant to clause 11.

11.6 The successful bidder's bid security will be discharged upon the bidder's acceptance of the advance work order satisfactorily pursuant to clause 26 and furnishing the performance security.

11.7. The bid security may be forfeited:

- (a) If a bidder withdraws his bid during the period of bid validity specified by the bidder on the Bid form, or
- (b) In the case of a successful bidder, if the bidder fails
 - i) to sign the contract in accordance with clause 27, or
 - ii) to furnish performance security in accordance with clause 27.

12. PERIOD OF VALIDITY OF BIDS:

12.1 Bid shall remain valid for 180 days after the date of bid opening prescribed by the purchaser, pursuant to clause 18.1. ***A bid valid for a shorter period shall be rejected by the purchaser as non-responsive.***

12.2 In exceptional circumstances, the purchaser may request the bidder's consent for an extension to the period of bid validity. The request and the responses thereto shall be made in writing. The bid security provided under clause 11 shall also be suitably extended. A Bidder accepting the request and granting extension will not be permitted to modify his bid.

13. FORMAT AND SIGNING BID:

13.1 The bidder shall prepare the bid in separate sealed envelopes for Technical bid and financial bid, clearly super scribing the name on the envelopes.

13.2 The bid shall be typed or printed and signed by the bidder or person/persons duly authorized to bind the bidder to the contract. The letter of authorization shall be indicated by written power-of attorney accompanying the bid. All pages of the original bid, except for unamended printed literature shall be signed by the person / persons signing the bid. The bids submitted shall be sealed properly (wax or PVC tape sealed).

13.3 The bid shall contain no interlineations, erasures or overwriting except as necessary to correct errors made by the bidder in which case such corrections shall be signed by the person/persons signing the bid.

14. SEALING AND MAKING OF BIDS:

14.1 The bidder shall prepare separate envelopes for technical as well as financial bids with clear marking of the same on the top of each envelope with wax or PVC tape. The two bids will further be sealed in an outer envelope with wax or PVC tape.

14.2 The inner and outer envelopes shall be:

- (a) Addressed to the purchaser on the following address:
Secretary, Tea Board of India, 14 BTM Sarani, Kolkata-700 001.
- (b) Bearing the tender number and the words 'DO NOT OPEN BEFORE 10.07.2017 (Due date).
- (c) The inner and outer envelopes shall indicate the name and address of the bidder to enable the bid to be returned unopened in case it is received late.
- (d) Tenders shall be dropped in the Tender Box at Ground. Floor, O/o Tea Board, and Kolkata. The responsibility for ensuring that tenders are delivered in time would vest with the bidder.
- (e) The purchaser shall not be responsible if the bids are delivered elsewhere.

14.3 If the outer envelope is not sealed and marked as required by Para 13.1 and 13.2, the purchaser shall not accept the bid. In case the inner envelopes are not sealed and marked as required by Para 14.1 and 14.2, the bid shall be rejected.

15 SUBMISSION OF BIDS:

- 15.1 Bids must be received by the purchaser at the address specified under Para 14.2 not later than 1 PM on 10.07.2017 (tender opening date).
- 15.2 The purchaser may, at its discretion, extend this deadline for the submission of the bids in accordance with clause 6 in which case all rights and obligations of the purchaser and bidders will be subjected to the deadline as extended.
- 15.3 The bidder shall submit his bid offer against a set of bid documents purchased by him for all or some systems/equipment as per requirement of bid document. He may include alternate offer as permissible as per his bid.

16 LATE BIDS:

Any bid received by the purchaser after the deadline for submission of bids prescribed by the purchaser pursuant to clause 15 shall be rejected and returned unopened to the bidder.

TENDER NO. 07/SECURITY/2017**17 MODIFICATION AND WITHDRAWAL OF BIDS:**

- 17.1 The bidder may modify or withdraw his bid after submission provided that the written notice of the modification or withdrawal is received by the purchaser prior to the deadline prescribed for submission of bids.
- 17.2 The bidder's modification or withdrawal notice shall be prepared, sealed, marked and dispatched as required in the case of bid submission in accordance with the provision of clause 14. A withdrawal notice may also be sent by e-mail/ FAX but followed by a signed confirmation copy, post marked not later than the deadline for submission of bids.
- 17.3 Subject to clause 19, no bid shall be modified subsequent to the deadline for submission of bids.

BID OPENING AND EVALUATION**18 OPENING OF BIDS BY PURCHASER:**

- 18.1 The purchaser shall open the bids in the presence of bidder/s or his authorized representatives who choose to attend at 3 PM on the due date. The bidders' representatives, who are present; shall sign in the attendance register, Authority letter to this effect shall be submitted by the bidder before they are allowed to participate in bid opening (A format is given on page no. 26)
- 18.2 A maximum of two representatives for any bidder shall be authorized and permitted to attend the bid opening.
- 18.3 The Bidder's names, Bid prices, modifications, bid withdrawals and such other details as the purchaser, at its discretion, may consider appropriate, will be announced at the opening.

19. CLARIFICATIONS OF BIDS:

To assist in the examination, evaluation and comparison of bids the purchaser may, at its discretion ask the bidder for the clarification of its bid. The request for clarification and the response shall be in writing. However, no post-bid clarification at the initiative of the bidder shall be entertained.

20 PRELIMINARY EVALUATION (TECHNICAL BIDS):

- 20.1 Tender will be evaluated in two phases. First, technical bid evaluation will be done only those bidders who qualify the technical bid evaluation will be allowed to participate/attend the commercial bid.
- 20.2 While doing the technical evaluation, Purchaser shall evaluate the bids to determine whether they are complete, whether any computational errors have been made, whether required sureties have been furnished, whether the documents have been properly signed and whether the bids are generally in order.
- 20.3 Arithmetical errors shall be rectified on the following basis. If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected by the purchaser. If there is a discrepancy between words and figures, the amount in words shall prevail. If the supplier does not accept the correction of the errors, his bid shall be rejected.
- 20.4 Prior to the detailed evaluation, pursuant to clause 21, the purchaser will determine the substantial responsiveness of each bid to the bid documents. For purposes of these clauses, in substantially responsive bid is one, which conforms to all the terms and conditions of the Bid documents without material deviations. The purchaser's determination of bids responsiveness is to be based on the contents of the bid itself.
- 20.5 A bid determined as substantially non-responsive will be rejected by the purchaser and shall not, subsequent to the bid opening, be made responsive by the bidder by correction of the non-conformity.
- 20.6 The purchaser may waive any minor infirmity or non-conformity or irregularity in a bid, which does not constitute a material deviation, provided such waiver does not prejudice or affects the relative ranking of any bidder.

TENDER NO. 07/SECURITY/2017**21. EVALUATION AND COMPARISON OF SUBSTANTIALLY RESPONSIVE BIDS:**

- 21.1 The purchaser shall evaluate in detail and compare the bids previously determined to be substantially responsive pursuant to clause 20.
- 21.2 The comparison for evaluations shall be the final quotation list as prepared on the basis of technical bid and financial bid evaluation of the services offered inclusive of all taxes and levies, charges.
- 21.3 The tender will be evaluated for offers quoted to provide all the services (engagement of Ex-Servicemen security guards & security supervisor, taken together).

22 CONTACTING THE PURCHASER:

- 22.1 Subject to clause 20, no bidder shall try to influence the purchaser on any matter relating to its Bid, from the time of the bid opening till the time the contract is awarded.
- 22.2 Any effort by a bidder to influence the purchaser in the purchaser's bid evaluation, bid comparison or contract award decision shall result in the rejection of the bid.

23. AWARD OF CONTRACT:

The purchaser shall consider placement of orders for commercial supplies on those bidders whose offers have been found technically (type-approved/validated by the purchaser), commercially and financially acceptable. Generally L-1 i.e. the lowest bidder is selected and is awarded with contract.

24. PURCHASER'S RIGHT TO VARY QUANTITIES AT TIME OF AWARD:

The purchaser reserves the right at the time of award of contract to increase or decrease by up to 25% of the quantity of goods and services specified in the schedule of requirements without any change in unit price of the ordered quantity or other terms and conditions.

25. PURCHASER'S RIGHT TO ACCEPT ANY BID AND TO REJECT ANY OR ALL BIDS:

The purchaser reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids, at any time prior to award of contract without assigning any reason whatsoever and without thereby incurring any liability to the affected bidder or bidders on the grounds for the purchaser's action.

26. ISSUE OF ADVANCE WORK ORDER OR LOI:

The issue of an Advance work Order or LOI (Letter of Intent) shall constitute the intention of Purchaser to enter into the contract with the bidder.

The bidder shall, within 07 (seven) days of issue of an advance work order, give his acceptance along with performance security in conformity with section VIII provided with the bid documents.

27. SIGNING OF CONTRACT:

The issue of work order shall constitute the award of contract on the bidder.

Upon the successful bidder furnishing of performance security pursuant to clause 26, the purchaser shall discharge the bid security, pursuant to clause 11.

That the agency is required to provide 09 Nos. Ex-Servicemen as security guards and 01 No. Ex-serviceman as Supervisor. The security guards and supervisor are required to man the main gate and garage gate and other gates as and when required. It is the duty of the security guards as well as the supervisor to provide all types of security inside the premises and also to ensure that the surrounding of the premises is not encroached by the unauthorized person like vendor, hawker etc. To check the material /property going out of the building and outside entering the building through the procedures of the gate pass etc. as laid down by the Authorized officer. To perform watch and ward functions including night patrol on the various points of deployment. To prevent the entry of stray dogs, antisocial elements, unauthorized persons and vehicles in to the building. To prevent unauthorized entry. The security personnel should be able to categorize the legitimate visitors without causing any embarrassment to them. The Supervisor is required to attend office for 6 days in a week from Monday to Saturday from 9-30 AM to 6-30 PM. He may be entitled for Board's holiday including Sunday.

The Security guards are required to attend office as per the shift detail prepared by the supervisor so that the main gate is manned by two (02) guards from 9-30 AM to 6-30 PM during the working days and if required on holiday. The garage gate should be manned by two security guards on 24 x 7 days basis.

Supervisor: He is responsible to the Estate Officer for maintenance of overall security, safety, housekeeping, fire preventive measures and reception desk. He will ensure that all instructions of the administration are strictly followed and there is no lapse of any kind.

Format of Contract Agreement

This agreement is made on this -----day of -----of between TEA BOARD a statutory body under the Ministry of Commerce and Industries, Govt. of India at 14, BTM Sarani (Brabourne Road), Kolkata-700001 duly represented by the Secretary, TEA BOARD hereinafter referred as "the BOARD" (which expression shall unless repugnant to the context mean and include its successors and legal representatives) of the FIRST PART

AND

----- sole proprietorship firm having its office at -----
-----duly represented ----- proprietor hereinafter referred to as
"the agency" (which expression shall unless repugnant to the context mean and include its successors and legal representatives) of the SECOND PART

WHEREAS the Board intended to engage a suitable agency for providing Security Supervisor and Guards only from the category of Ex Serviceman (Discharged/Released from Army, Navy and Air Force) who are medically fit and capable to perform duty in shifts in the Board's Head office at Kolkata and for the said purpose the Board issued an open Tender notice No. ----- for inviting willing bidders

AND WHEREAS by a letter of intent with reference No. ----- the agency having it's office at ----- was informed about the acceptance of it's Tender submitted against Tender notice No. ----- for the period at a price and upon the terms and conditions herein contained. The agency has also deposited performance security for an amount of -----

AND WHEREAS on the requisition of the BOARD the agency has agreed to provide 09 (nine) Nos. security guards (only Ex-Servicemen), 01(one) No. security supervisor (only Ex-Serviceman), on contractual basis to BOARD as per the scope of work narrated below for the safety and security and other related and associated work of the aforesaid premises of the BOARD effectively and efficiently. The offer and acceptance were made on mutual agreement with effect from ----- for a consideration sum of Rs. -----
-----per month including Service Tax/GST @ ----- and all other applicable Taxes and charges for providing a total 10 Nos. Ex Serviceman as stated before and also in the Tender form.

AND WHEREAS it is also agreed that as and when it is required to engage more staff the agency will provide those staff as per the agreed rate and considering the minimum rate declared by the Govt. of West Bengal. No overtime payment or any other allowance/charges will be paid. The terms and conditions given in the Tender are also part of the Deed of Agreement and the agency has to follow those terms and conditions in letter and spirit.

NOW THIS DEED OF AGREEMENT WITNESSES AS FOLLOWS:

I. SCOPE OF WORK:

(a) That the agency is required to provide 9 Nos. Ex-Servicemen as security guards and 01 No. Ex-serviceman as supervisor, the security guards and supervisor are required to man the main gate, garage gate, parking slots and any other gates or area as and when required. It is the duty of the security guards as well as the supervisor to provide all types of security inside and around the premises and also to ensure that the surrounding of the premises is not encroached by any unauthorized person like beggars, vendors, hawkers etc. If any portion/spot in the surrounding area is encroached by any unauthorized person/agency during the contract period then it is the responsibility of the agency to remove such encroachment before submission of monthly bill. It is the duty of the security guards as well as the supervisor to ensure that 05 Nos. parking slots on Brabourne Road allotted by KMC against payment are occupied by office car only. No private car should be allowed to be parked in the allotted parking slots without explicit order of the Competent Authority of Tea Board. The final bill and performance security money will be released only when the surroundings is free from any encroachment.

(b) The supervisor preferably a computer literate person should have the knowledge to handle both types of metal detectors viz. door frame metal detector and hand held metal detector and fire extinguishers as well as fire hose. The supervisor has to keep a close watch on CCTV monitor along with the receptionist from the reception desk. The supervisor is to erase/manage the memory of the PC connected with the cameras. He has to write down the number of persons entered IN and OUT through Door frame metal detector and keep the record in the visitors' register daily. He is to reset the visitor counter installed in the Door frame Metal detector at the end of the day.

(c) The supervisor is also to supervise the work performed by the house keeping staff engaged at Tea Board, Kolkata and in some occasions may be required to supervise other staff engaged at Guest house at Salt Lake.

II. THE SCHEDULE OF WORK

(a) The supervisor is required to attend office for 6 days in a week from Monday to Saturday from 9.30 AM to 6.30 PM and if required he may be required to attend office on Sunday and other holidays without any extra payment. However, he may be entitled for Board's other holidays including Sundays.

(b) The security guards are required to attend office as per the shift detail prepared by the supervisor so that the main gate is manned by two (02) guards from 9.00 AM to 6.30 PM during the working days and if required on Saturday, Sunday and other holidays without any extra payment. The garage gate should be manned by two (02) security guards on 24 X 7 basis.

III. JOB RESPONSIBILITIES

(a) Supervisor: He will report to the Estate Officer for maintenance of overall security, safety, housekeeping, fire preventive measures, reception desk, arrangement of hire car, maintenance of Guest house at Salt Lake as per the order/direction by the Estate Officer/ Secretary/ Deputy Chairman/Chairman. At no point of time he is authorized to act in contravention of the order given by the officers mentioned above. If it is found or brought to the notice of the authority that he has acted or tried to act in contravention of the order given by the above mentioned officers then an amount of penalty @ Rs.500 per violation will be imposed and deducted from the monthly bill/performance security money.

(b) Security Guards: They are to report to the Estate Officer through the supervisor. Besides manning the gates and operation of the fire fighting equipments a few other related and associated tasks are required to be performed by the security guards such as maintaining one register for garage out/in of the office cars. They have to hoist and lower the National Flag at every dawn and dusk respectively. They have to switch on/off external lights viz. neon sign, flex lights and security light of the building. After working hour they have to ensure that all the internal lights, fans, AC machines, UPS are switched off and office doors are closed. They have to ensure that all the water taps are closed and water is not wasted. They have to operate the pump motor to lift water whenever required. The security guard should act as per the order/direction by the Security Supervisor/Estate Officer/ Secretary/ Deputy Chairman/Chairman. At no point of time he is authorized to act in contravention of the order given by the officers mentioned above. If it is found or brought to the notice of the authority that he has acted or tried to act in contravention of the order given by the above mentioned officers then an amount of penalty @ Rs.500 per violation will be imposed and deducted from the monthly bill/performance security money.

(c) The Security Supervisor and Security guards should ensure that no unauthorized person stays back in the office after office hour i.e. beyond 6.15 PM and enter into the office on Saturday, Sunday and other holidays. However, persons obtained written permission from the Competent Authority will be allowed to work beyond office hour and also on Saturday, Sunday and other holidays. Two separate registers are required to be maintained one for those who stays back after office hour and another for those who are permitted by the Competent Authority to attend office on Saturday, Sunday and other holidays.

IV. SURPRISE CHECK: That the agency should carry out at least two surprise checks at mid/late night without any prior intimation to the Security Supervisor or Security guards to check the alertness of the security guard on duty. The report of the surprise check is to be shown to the Estate Officer on the very next day and it should be submitted along with the monthly bill.

V. PLACE OF DUTY: That all the persons will be engaged at Head Office at Kolkata and they may also be deployed at Guest House at Salt Lake or any other places in Kolkata as directed by the Competent Authority of Board for which no extra payment will be made.

VI. TERMS OF PAYMENT: That the Board has agreed to make the following payments toper month including all applicable Taxes and charges during the period of engagement as indicated below and the amount payable has been accepted by the agency.

1. Supervisor, Ex-Serviceman each: Rs.
2. Security guard, Ex- Serviceman each: Rs.

The above rates are inclusive of all statutory payments to be paid by the agency under various legislation like Minimum Wages Act, P.F, E.S.I and Bonus Act including Service Tax/GST @----- and other charges whatsoever. The agency should ensure that the minimum wages are paid to the persons engaged. Board will pay the minimum wages as and when it is revised by the Govt. of West Bengal.

VII. PAYMENT: That the monthly bill is to be submitted by the AGENCY to the Board on the 1st working day of the following month which may be paid by the 15th of the month with a cheque or through RTGS/NEFT in favour of -----
----- . However, payment shall be released only if it is accompanied by the proof of the following

- a) Certified attendant sheet
- b) Signed copies of Surprise check at night at least two
- c) Duty roster for the succeeding month
- d) ESI payments
- e) Provident Fund payments
- f) Receipted payment of wage sheet to staff for the preceding month
- g) Deposit challan of Service Tax/GST

VIII. PERFORMANCE SECURITY: That the agency shall furnish a performance security bond/ pay in cash or through NEFT equal to the amount of 10% of the contract value as per the format given in section VII of the bid document. The performance security will be refunded after the expiry of contract period or termination of contract.

IX. COMMENCEMENT OF AGREEMENT: That the agreement shall come into force from 01.09.2017 for a period of 01 (one) year which may be extended with mutual consent. Incase due to unavoidable circumstances the parties are not able to agree mutually for extension of contract period, the agency shall continue to render services till any alternative arrangement is made with the same terms and conditions.

X. REFUND OF SECURITY: Payments of Performance Security shall be released only if it is accompanied by the proof of the following

- a) Already handed over the complete establishment including all materials and equipments if any handed over to the AGENCY at the time of entering into contract.
- b) Already vacated rest room in the premises that may have been allotted to the AGENCY for discharge of the contractual obligation.
- c) Already handed over the entire premises to the Board in the same condition without any encroachment by any person/body as was at the time of entering into contract

XI. PREMATURE TERMINATION OF AGREEMENT: That either party is entitled to terminate this agreement due to some unavoidable circumstances by giving a minimum notice period of two months in writing or in lieu of one month's payment or till an alternative arrangement is made whichever is later.

XII. DEPLOYMENT: That the day to day deployment of the security personnel shall be made by the supervisor of the AGENCY as per the requirement of the Board in consultation with the Estate Officer of any other official so designated by the BOARD for this purpose.

XIII. ENFORCEMENT OF STATUTORY LAWS: That the agency shall ensure and binding to comply with the relevant prevailing statutory laws. The agency is furnishing the following Registration Nos. / Code Nos. and Account No. for enforcement of statutory obligations.

- a) A/c No.
- b) Branch
- c) IFSC
- d) E P F
- e) E S I
- f) Service Tax Code/GST
- g) PAN
- h) Aadhaar No

If it is brought to the notice of the BOARD by the appropriate authority about default of payment of statutory dues the same shall be deducted from the monthly payment/performance security of the AGENCY and shall be deposited before the appropriate authority on demand.

XIV. ACCOMMODATION: That the BOARD may provide only changeover room for security personnel with common toilets and bathroom with free electricity and water.

XV. OPERATIONAL REQUIREMENT: That the AGENCY shall provide at its own cost uniforms (twice during the subsistence of this agreement) duty enforcement suitable serviceable tools i.e. Sticks, Torch light, Batons and Whistle etc. to the security personnel.

XVI. REPLACEMENT OF MANPOWER: That in case of any absence of manpower in any day due to sickness, short leave, long leave or any other reasons whatsoever the vacancy shall be taken care of by the AGENCY with immediate suitable substitution against the vacancy.

XVII. LIMITATION OF AGE FOR SECURITY PERSONNEL: That since the persons deployed as security guard and supervisor all are Ex-Serviceman, so the age of those personnel may vary but should not be more than 55 years of age. They must be physically and mentally fit for duty.

XVIII. LOSS AND DAMAGES: That any loss and damages caused to any of the assets, materials, property of the BOARD due to negligence (willful or otherwise) of the personnel engaged by the AGENCY shall be compensated by the AGENCY, else shall be recovered by deducting the actual loss in terms of monetary value from the monthly payment payable to the AGENCY.

XIX. ARBITRATION: In the event of any dispute or difference relating to this agreement shall be referred to the Chairman, Tea Board also may appoint sole arbitrator as per the provision of Arbitration and Conciliation Act 1996. The venue of arbitration shall be Kolkata and the language shall be English.

XX. DECLARATION: That the AGENCY hereby declares that it shall not act in contravention with the provisions of "The Private Security Agency (Regulation) Act, 2005" and the "West Bengal Private Security Agency (Regulation) Rules, 2007" and any other Acts, Rules, Regulations, Orders enforced for the time being in order to regulate the employment of those persons engaged by the agency. The AGENCY further declares to indemnify and compensate and hold the BOARD harmless against any and all Losses resulting from or arising out of any action brought against BOARD arising out of this Agreement.

XXI. INDEMNITY: The AGENCY hereby indemnifies to hold the BOARD harmless against any and all losses resulting from or arising out of any action brought against BOARD arising out of this Agreement.
