The Educational qualifications for the posts: The applicant must be a graduate in Agriculture/Botany from a recognized University.

Desirable qualification and Experience: Preference will be given to candidates having Post Graduate Degree/Diploma in Agriculture/Botany/ Tea Technology.

Two years working experience in the capacity of Assistant Manager or equivalent in a Tea Estate/ Assistant Advisory officer in a Tea Research Organisation will be considered as additional qualification.

Age Limit: 32 years as on 30.04.2012 Relaxable for reserved categories as per relevant Govt. orders.

Period of Probation: Two Years

The applicants fulfilling the above eligibility conditions are to submit application as per the prescribed format given below along with the copies of following documents are to be sent by Registered Post/Speed Post to the **Secretary**, **Tea Board**, **14 BTM Sarani**, **Kolkata 700 001** :

- 1. Copies of educational qualification, experience and date of birth
- Two recent passport size photos one to be signed and pasted on the top right hand corner of the application. The second to be enclosed separately in a small envelope;
- 3. One self addressed envelope of size 23 x 10 cm affixed with postal stamp of value 5/-
- One Indian Postal Order or Bank draft for `100/- drawn in favour of Tea Board, payable at Kolkata towards application fee. SC/ST/PH/Ex-SVM candidates are exempted from payment of application fee. Relevant certificates must be attached.

Last date for receiving application is 11.05.2012.

Post applied for must be written on the envelope clearly. Applications received after due date (for whatsoever reason) shall not be entertained.

Method of Selection

The applications will be shortlisted by taking into consideration the qualification and experience etc. Such shortlisted candidates are to sit for written test to be held in the month of May/June, 2012.

The candidates successfully **clearing** the written test will have to appear for personal interview on the dates which will be communicated by email to the e-mail id provided by them in the application form.

CONDITIONS :

- (a) The candidates applying should ensure that they fulfill all eligibility criteria. Their admission to all the stages of selection process will be purely provisional subject to satisfying the prescribed eligibility criteria mentioned in this advertisement.
- (b) Pre-requisites are minimums and mere possession of the same does not entitle the candidate to be called for the selection process.
- (c) If the candidate knowingly or willfully furnishes incorrect or false particulars or suppresses material information, he/she will be disqualified and if engaged, shall be liable for dismissal without any notice or assigning any reasons whatsoever.
- (d) The decision of the Tea Board in all matters relating to selection shall be final and no individual correspondence will be entertained.
- (e) The Tea Board reserves the right to cancel the Advertisement fully or partly on any grounds and such decision of the Tea Board will not be notified or intimated to the candidates.
- (f) Employees working in Government/Semi-Government Undertaking will have to send their application through "Proper Channel". However they may send an advance copy so as to reach Tea Board before the due date. In the even to clearing the written test, they have to produce No Objection Certificate from their organizations/employers at the time of interview.
- (g) The application must be submitted in the Proforma given in this website in the same order preferably typewritten on foolscap paper.
- (h) Date of birth as per Secondary School Certificate (SSC) and age as on 30.4.2012 should be mentioned.
- (i) A candidate should submit only one application. Submission of more than one application may lead to rejection of all the applications submitted. Mere submission of the application does not confer any right on the applicant to be called for written examination or personal interview.
