**STATUS REPORT ON THE STEPS TAKEN SO FAR BY TEA BOARD TO PROTECT
THE INTELLECTUAL PROPERTY RIGHTS OF TEAS OF INDIAN ORIGIN**

The Tea Board of India is an autonomous and statutory body created under the Tea Act, 1953 and it was established for the purposes of regulating the Indian tea industry and protecting the interests of tea producers in India. All teas produced in the tea growing areas of India are administered by the Tea Board. Among the Indian teas administered by the Tea Board are the world famous Darjeeling, Assam and Nilgiri.

Tea Board has spent a substantial amount in the marketing and promotion of these three tea products in the last two decades. Tea Board is perhaps one of the handful of registered proprietors of GIs in India who has put in a robust enforcement program for its tea products which are GIs. To begin with, the Tea Board holds registrations for these tea names in India and several foreign jurisdictions. The watch agency appointed by the Tea Board has helped the Tea Board identify and act against all instances of misappropriation of these tea names not only in India but globally. Tea Board has received numerous orders of courts and tribunals around the world including from India which uphold the rights in the names of these teas as geographical indications. It is also noteworthy that in many instances, upon receiving a demand letter from the Tea Board asserting the rights of the relevant tea trade in the respective names, the violators have voluntarily withdrawn their applications and provided undertakings to the Tea Board that they will no longer misuse these names.

It is also submitted that despite the above listed efforts in protecting the goodwill and property in these three tea names, both domestically and globally, the Tea Board has been continuously warding off constant attack on these names by third parties who choose to adopt these for non-origin teas or on services and dissimilar goods. The Tea Board is constantly and relentlessly engaged in legal proceedings in this respect. If the home protection for these three teas can be enhanced by offering additional protection under Section 22(2), then it would provide an additional basis for the Tea Board to defend the rights of the relevant tea trade in these names.

Now, time has come to let the stakeholders know about the steps taken so far by Tea Board to protect the intellectual property rights of Teas of Indian origin by disclosing the details about the oppositions filed by the Board in India against those applicants (**Annexure-I**) who have tried to usurp the goodwill of the marks owned by the Board. Another objective of making the details public is to spread awareness amongst the potential users who intend to use various marks of the Board under license.

For the benefit of the stakeholders the Board has been allowing the following marks to be used:


