ORDER

The Board vide Notification No. 12(17)/LC/2008/Part-III/213, dated 12.09.2022, issued directives for closure of manufacturing activities for onset of winter of 2022, which are as follows:

iii.	Last date for intimation / declaration to Tea Board by all tea manufacturing units regarding closure of their manufacturing	6 th December 2022	21 st December 2022
iv.	Last date for completion of sorting, gapping, packing (CTC & Orthodox/Green tea) and moving the packed teas to notified packed tea storage area with invoice marking	16 th December 2022	31 st December 2022 (for CTC Tea manufacturing) 5 th January 2023 (for Orthodox / Green Tea manufacturing)

The Board has been receiving representations from various gardens of North Bengal to allow them to pluck and manufacture tea as because some sections of the gardens are producing pluckable shoots.

In view of the above, it has been decided by Registering Authority under the Clause 13(3) of the Tea (Marketing) Control Order, 2003 that those gardens which can produce Orthodox Specialty teas out of pluckable green leaves, if any, can start such process without waiting for any formal order / clarification of the Board.
