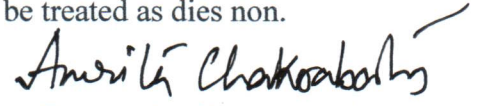
That, after submission of resignation, as Shri Bhattacharya had not submitted the office laptop/hard disk, various communications were issued to Sri Bhattacharya.
